MEMORANDUM OF SOCIETY

1. **NAME OF THE SOCIETY:** The name of the Society shall be -

3. **WORKING AREA: ALL OVER INDIA**

4. **AIMS AND OBJECTS:** Aims and objects of the Society for which the same is established, are as under:

(a) To work for National Integration and unity of India. To aware the general public about their rights and duties and and to promote it seminar may be held for educational and Socio-economic upliftment.

(b) To keep environment free from pollution, constriction of public toilets and its operation. Even the readymade toilet which is in bad condition may be operated for public welfare.

(c) To construct low cost sanitary units (house hold latrines) and conversion of dry latrines in pour-Flush

(d) And to liberate the scavengers who are carrying night soils over their Head.

(e) For Sanitation, House keeping work may be taken at Hospitals, Collages, Schools, Technical Schools and Collages, Government & Private Offices or Buildings and Road Bus-stands, Railway Stations and Airports.

(f) To establish Hospitals, Clinics, Diagnostics centre and mobile unit for providing diagnostics clinical examination and medical treatment to the people.

(g) By construction/conversion low cost individual toilets in house with a view to have better and hygienic living condition, avoid environmental pollution and help the Government in their goal to eradicate scavenging completely.

(h) To maintain Bio Gas plants based on either human excreta or animal dung or even both if desired by the concerned local bodies or Government agencies for use of gas or generate electricity for lightening, heating or other purpose.

(i) To plan laying drainage and sewer lines and advise improvement in the existing drainage and sewerage system.

(j) To construct, maintain, manage and control Barat Ghar, Grih Kalyan Kendra, Creche, orphanage, Night shelters, Bus-Q-Shelter, Old people Home, Women/Girls Hostels/Homes for their survival with dignity, honor and independence through various social welfare measures.

(k) To work for animal welfare, protection, preservation of endangered species, prevention of cruelty against animals and develops suitable means in this direction to create awareness among mass regarding all these matters.

(l) To take up effective but reasonable and lawful steps for the eradication of Social evils such as Dowry system, child marriage (Bal Vivah), child labour, wastage of money in the various functions and use of intoxicated drugs/Wine/ smack etc.

(m) To promote the use of non-conventional energy for the sake of community benefit and conduct research and development work to fine out alternative sources of Energy.

(n) To work against Global Warming to save our EARTH, and to work keeping environment free from pollution.

(o) To receive financial and non-financial assistance from Government, non-Government organization, National- International Agencies, Banks and any other legal entity or individuals.

(p) To accept donation, grant, presents, gifts and other offering in the shape of moveable and /or immoveable properties for the attainment of the aims and objects of the Society, And to purchase/acquire the land/ or the building in the name of the Society and make construction thereupon.

(q) To engage, employ or hire appropriate workers, legal experts and other professionals, attorneys, managers and agents for the work and furtherance of the aims and objects of the Society and to pay honorarium/Consultancy or fees.

(r) To formulate and implement programmers for economic and social development of poor women, blind women and children, particularly migrated labours women and girl child belonging to the land-less.

(s) To work in the field of education, research, science and technology.

(t) All the activities shall be Non profitable and shall be done on "NO Profit-No Loss" basis.

(u) All the income, earning moveable/ or immoveable properties of the Society shall be solely utilized and applied towards the promotion of its aims & objects any as set forth in the Memorandum of the Society and no profit thereof shall be paid or transferred directly or indirectly by way of dividend, bonus, profits or in any manner whatsoever to the present or past member of the Society or to any person claiming through any one or more of the present or the past members. No members of the Society shall have any personal claim on any moveable/ or immoveable properties of the Society or make any profit, whatsoever, by virtue of this membership.
